Outreach Committee Meeting Notes

November 5, 2018: 6:00 – 7:00 p.m. (EST) (605) 468-8018 Pin 368151

Discussion Topics:

1. Funding for North Lakeland Group to air PSA as per description emailed on Oct. 30th.

Kim talked with Mary C. from North Lakeland Group on Nov. 2nd and learned that, according to Cathy at the WSO, paid advertising may violate Tradition 6 and providing Outreach Funding to an individual group may violate Tradition 7.

<u>Tradition 6</u>: Our Family Groups ought never to endorse, finance or lend our name to any outside enterprise, lest problems of money, property and prestige divert us from our primary spiritual aim; but although a separate entity, we should always cooperate with Narcotics Anonymous.

<u>Tradition 7</u>: Every group ought to be fully self-supporting, declining outside contributions.

- Rosemary H. gave an overview of the previous Outreach Committee's activities which included compiling a list of facilities in FL, providing Nar-Anon outreach tables at various events, e-mailing a monthly "Outreach Challenge", and providing outreach guidance to groups in the Region.
 September is Recovery Month. Archived Outreach MoM's are posted on the FL Nar-Anon website.
- 3. Phyllis S. (a long-time Nar-Anon member who has been active in Outreach and who is soon moving to Arizona) shared that she takes copies of the Outreach information from the Nar-Anon website to her group, includes "Outreach" in the group's Business Meetings, displays the Nar-Anon banner (pull-down sign) at Outreach events, and provided a Nar-Anon Meeting List to a local facility. She provided the link to SAMHSA's list of Opioid Treatment Facilities: https://dpt2.samhsa.gov/treatment/directory.aspx

She also suggested that it would be very helpful for one or more members of the Outreach Committee to participate in the WSO Outreach Roundtable Discussion. (Kim will present the Outreach Roundtable information, sent by Phyllis, at the next Outreach Committee meeting.)

- 4. Previous Action Items:
 - Belle: There is a facilities list for FL but it probably requires updating.
 - <u>Jim</u>: Outreach Packets were sent to Mark (Naples mtg) and Bob (Ft. Walton). There are no restrictions on giving out the Business Cards. Each person giving out a card decides if he/she wants to include their phone number on the card.
 - <u>Kim</u>: The Outreach Committee meeting information is posted on the FL Nar-Anon website and the monthly Meeting Notes will be sent to the Webmaster for posting also.

Action Items:

- Belle and Rosemary will work to create a seasonal Outreach Challenge Flyer based on the monthly challenge published on the Nar-Anon website. The wording on the flyer will be reviewed by the RSC before the flyer is mass distributed. A copy of the Outreach Cover Letter(s) from the Nar-Anon website will be attached to the mass e-mail also.
- Kim and Karen will begin calling each group to establish contact, to learn about outreach activities being done in individual groups, and to offer outreach support if needed. During the phone call they will ask if the group has an Outreach Coordinator.
- Kevin will contact the WSO to learn how he can obtain a 501(c)3 letter for Alabama. Jim has a copy of the 501(c)3 letter for Florida.
- Viviane will confirm the meeting location(s) in Birmingham via the Nar-Anon website and contact Rand M. to ask if the entire state of Alabama is included in the FL Region.
- Karen will begin to compile a list of facilities in L.A. (Lower Alabama).
- Kim will call Bonnie N. (World Outreach Committee) and Sheryl H. (Nar-Anon Board Member) for guidance regarding the use of Regional Outreach Funds to support individual groups and to pay for PSA's in print (signage), video (t.v.) and audio (radio). Kim will also ask about raising funds through garage sales, bake sales, etc.

 The cost for a portable tri-pod stand and a 24 x 36 color sign are approximately \$30 each at Staples.
- 7. As an "Outreach Challenge", ask groups to make a list of nearby NA groups and place Nar-Anon pamphlets (with permission) at those meetings.

Discussion Topics:

- 1. Information in the GSL provided clarification on Nar-Anon's position regarding "paid advertising" and "outside contributions"
 - Per Page 10-1 in the GSL (2016), groups are allowed to pay for an ad to make the community aware of Nar-Anon.
 - Per Page 8-2 of the GSL, Outside Contributions are from sources outside of the Nar-Anon fellowship.
- A request was made to consider reimbursement for literature purchased for Nar-Anon's participation (Dec. 22 – 30) in the South Dade Area of NA's 24 hour meetings "Coming Out of the Dark". The request was approved unanimously by the Committee.
- After the November meeting, Phyllis emailed Kim a summary of the NA conventions held in South Florida. Florida NA convention dates are available on the NA.org website. (During the January meeting, Kim will ask if there is willingness from a committee member to take responsibility for monitoring upcoming NA conventions and contacting Nar-Anon groups in the vicinity to learn if Nar-Anon is planning to participate.)
- The quarterly, one-hour, WSO Outreach Roundtable Meetings will begin on January 27th, 2019 at 4:00 pm EST (3:00 CST). The meetings will be held via Skype.
